

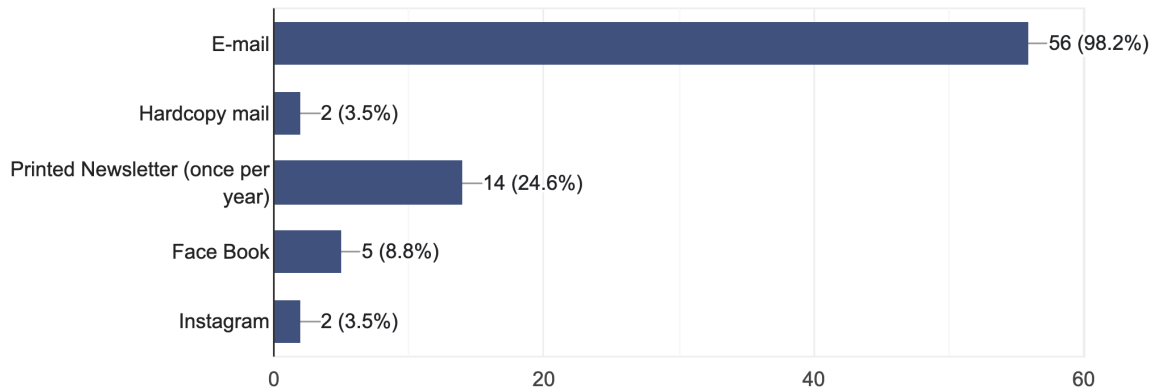
April 2022 SLA Survey Results

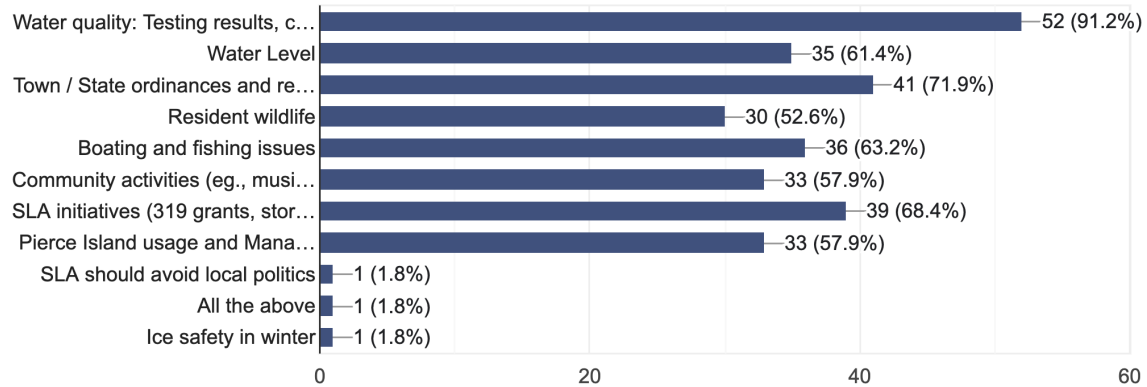

What topic(s) most interest you? (Check all that apply)

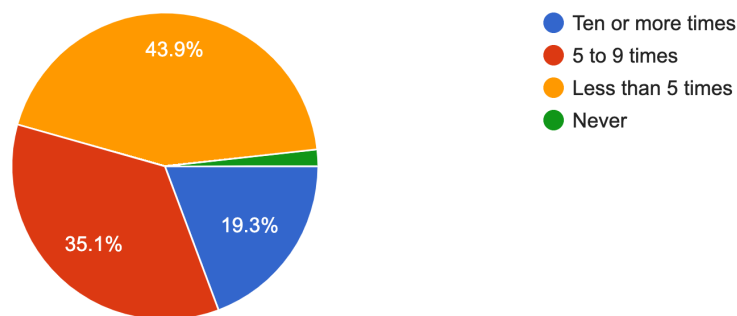

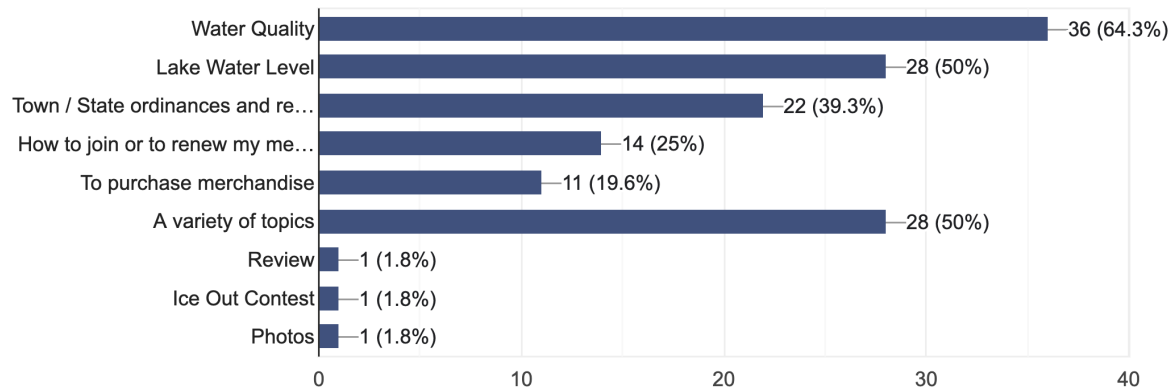

When I go to the SLA website, I am looking for information on... (Check all that apply)

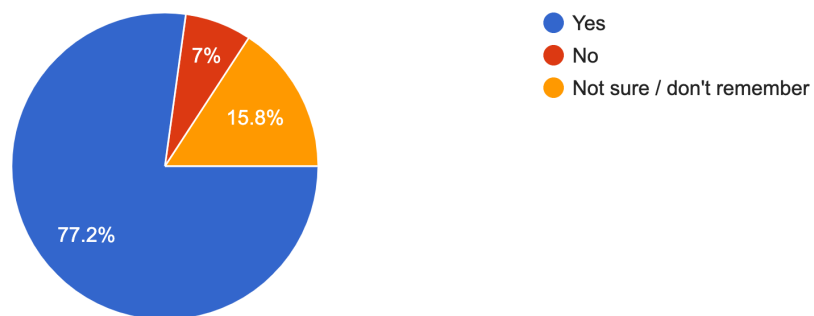

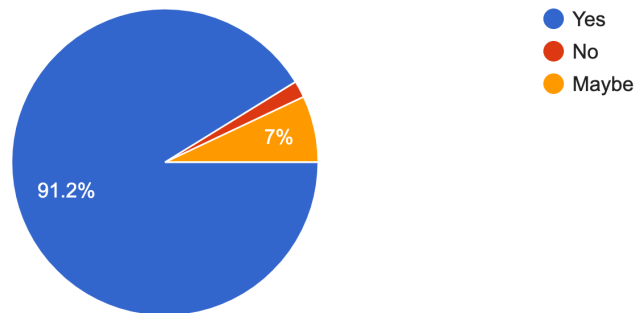
